19-08-01 Board Vacancies

Board member Jon Rorie made a recommendation to have the Board members vote to fill the recent Chairman Position vacancy. He recommended Ms. Patti Kadkhodaian. Mr. Paul Salvatore second the motion. Board voted and was unanimous 3-0 to nominate Ms. Patti Kadkhodaian as the new Chairperson.

- VI. New Agenda Items.

19-10-01 Board Applicants

Board member Jon Rorie explained to the Board the selection process changes made by the City Council when we have Board member vacancies.

Two applicants were introduced to fill a vacant Board position. Mr. Michael Royer, Apsilon Hotels and Mr. Scott Lovejoy, Peachtree City Hotel & Conference Center.

Mr. Rorie explained that both applicants come highly qualified, he recommended Mr. Scott Lovejoy for the Board member position. Noted that Mr. Royer is with Apsilon Hotels and since the outgoing Chairman, Mr. Adlington was also with Apsilon Hotels it would be good to rotate members. Chairperson Ms. Kadkhodaian agreed, that it was a good idea to alternate. Board member Paul Salvatore commented that he agrees with the rotation selection and that it makes it hard because both applicants are well qualified. Board member Donna Soper noted that it makes sense not staying with the same hotel business.

Board member Paul Salvatore made a motion to select Mr. Scott Lovejoy to fill the open Board position. Seconded it by Board member Jon Rorie. Board members voted and the results were unanimous 4-0.

Kim Hughes presented the CVB Sales Brief to the Board. Notes that they are making good progress.

The next scheduled Marketing meeting is scheduled for Wednesday, October 23, 2019, at 9:00 a.m., at the Hilton.

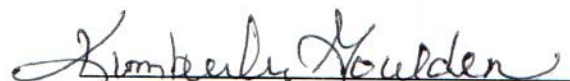
The next Board of Directors regular meeting will be for the Holiday Luncheon, Friday December 6.
